Proceeds from the event allows us to continue our mission of: offering support to women diagnosed with gynecologic cancer and their families, increase public awareness of gynecologic cancer symptoms, provide resource services, and to advocate for quality care, education, and support.

As an organization working to support women with gynecologic cancer, we know the facts all too well. Ovarian cancer is the 11th most common cancer among women and the 5th leading cause of cancer-related deaths. The majority of women are not diagnosed until the cancer is in a late stage. Only 46% of these women will live beyond 5 years. We need your help to turn this around.

C.A.R.E. is a not-for-profit organization dedicated to these women. We currently provide a monthly support group for women diagnosed with gynecologic cancer and their families. In addition, C.A.R.E. volunteers, who are survivors, offer High Tea twice a month to patients currently in treatment. High Tea provides patients and their families the opportunity to meet survivors who themselves were patients at the infusion center. C.A.R.E. volunteers and Board Members routinely distribute symptom cards to physician practices, churches, and other community settings in order to raise awareness of gynecologic cancers. Some of our services have evolved since COVID: we now host hybrid support group meetings and High Tea has been put on hold, but we continue to offer education and assistance to women with gynecologic cancer and their families.

## General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

**Future developments.** For the latest information about developments related to Form W-9 and its instructions, such as legislation enacted after they were published, go to [www.irs.gov/FormW9](http://www.irs.gov/FormW9).

### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-INT (interest earned or paid)

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

*If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding, later.*
